Creekside Pet Care Doggie Daycare is so pleased to have your dog join us for time of off-leash socialization, play, and TLC. Please read and sign the following application which includes a waiver of liability for your protection and ours .

For eligibility, I understand that I must show written proof of current vaccinations for my pet as administered by a licensed veterinarian: Rabies, Distemper/Parvo and Bordatella (Bordatella is required every 6 months) and that my pet must be free of external parasites, or the pet will be vaccinated/treated at cost to me. I understand that if my pet is over the age of 6 months, he/she must be spayed/neutered to attend daycare. Although the doggie daycare environment is a safe and well supervised area, I understand that rough play can be an inherent part of dog behavior in daycare. Despite trained staff and constant supervision, play may be come too rough and an injury to my dog may occur. Should my dog require immediate treatment before I or my emergency contact person can be reached for authorization, I hereby authorize treatments and medications as deemed necessary by the CPCC veterinarian on staff, and will be responsible for all associated cost. For minor injuries, we will attempt contact as well to apprise owners of the situation. Although obviously sick or unvaccinated pets are not allowed into the daycare area, I understand that I am placing my dog in an area in which communicable diseases may pass between dogs. If following a daycare date, my dog shows signs of illness, I may not hold Creekside liable for any inadvertent exposure my pet may have received, and that if I request an exam, treatment, or medications for my dog, it will be done at full cost to me.

Regarding behavior, if the staff determines that my dog shows excessive stress or aggression in daycare, I give permission for Creekside Pet Care Center to transfer my dog to kennel daycare with every effort made to inform me of the change in the situation. I understand that my dog may be prohibited from daycare upon staff recommendation. I agree to abide by the drop off times of 7:30am M, T, Th, Fr and 7:00am on Wed. as well as the pick up time of 6:30pm M-F and to call no later than 5:45pm if a delayed pickup may occur. I understand in the event of habitual lateness after the closing time of 6:30pm there will be \$1.00 per minute late fee for up to 10 minutes, after which my dog will be transferred to the kennel for an overnight stay for which a boarding charge on my account will incur.

“THREE STRIKES” POLICY for Doggie Daycare: While all dogs must pass the preliminary temperament test to be eligible for Creekside’s daycare program, some behaviors may be revealed only after a dog has attended daycare for a number of days. If conduct deemed unacceptable or dangerous occurs and after our staff has taken measures to correct and retrain the offending dog, we will inform the owner of 1st strike on their dog’s documented record and discuss solutions. A second offense, whether related or not to the previous issue, will result in a 2nd strike. These reports will give owners time to begin or to reinforce training sessions outside daycare in order to avoid a 3rd and final strike and revocation of daycare eligibility. Drawing blood can constitute an automatic ban. This policy is in place to maintain safety, minimize stress, and create a fun experience for our clients’ dogs and our workers. Our daycare is not a training ground for dogs with difficult issues nor is it the job of our attendants to devote extensive attention to a single dog’s problem issues. Creekside Pet Care Center also reserves the right to immediately deny any dog’s eligibility at any time by decision of our directors or daycare staff in the event that a dog causes severe injury or displays dangerous aggression. Loss of daycare privileges does not affect other available services at Creekside Pet Care Center.

I accept sole responsibility on behalf of myself and any parties authorized on my account for all payments, in full, incurred at this facility. By signing below, I understand and agree to the terms stated above, and I release and hold blameless Creekside Pet Care Center, its staff, and the owners of other dogs attending daycare, voluntarily waiving all liability of any nature.
